

It's this sort of forward planning that contributes to the country's sustained progress.

In the same month, on September 15, the UAE played a central role in another historic event. This historical achievement paves the way for an overall peace process and is a realistic response to the geopolitical changes and the security and development challenges facing the region, along with the opening of new avenues for economic prosperity.





Khalifa issues new law to crack down on financial crimes



PRESIDENT His Highness Sheikh Khalifa bin Zayed Al Nahyan has issued a law regulating the Abu Dhabi Accountability Authority to enhance the monitoring of public finances, and to strengthen

integrity, transparency, accountability and governance in public offices.

Directly working under His Highness Sheikh Mohamed bin Zayed Al Nahyan, Crown Prince of Abu Dhabi and Deputy Supreme Commander of the UAE Armed Forces, the Authority was established by the new law as a financially and administratively independent entity, and has the full legal capacity to practise its activities to achieve its objectives.

The law has expanded the authority's roles and responsibilities to guarantee effective financial monitoring and efficient financial operations at companies for whom 25 per cent plus of their capital is owned by the government, compared to 50 per cent previously. The objective is to ensure optimum use of public resources across Abu Dhabi.

covered by Abu Dhabi Accountability Authority: (1) to implement financial monitoring for all respective government entities; (2) to ensure they are committing to their obligations, objectives and activities; and (3) to oversee the efficiency and effectiveness of the electronic monitoring systems controlling those entities' finances. Based on Article 31 of this law, entities to be monitored by Abu Dhabi Accountability Authority include: local departments, municipalities, authorities, corporations, councils, general secretariats, courts, police and security entities, centres, offices, universities, institutes, funds, markets, public incorporated bodies, companies either directly or indirectly fully owned by government entities or government companies, or companies for whom 25 per cent of their capital is owned by the government or by government entities.

Khalifa bin Zayed abolishes Israel Boycott Law ahead of peace accord

The law defines three key packages to be

PRESIDENT His Highness Sheikh Khalifa bin Zayed Al Nahyan issued a Federal Decree-Law No. 04 of 2020, abolishing the Federal Law No. 15 of 1972 regarding boycotting Israel and the penalties thereof.

The federal law came out weeks leading to the 'Abraham Accord' signed between His Highness Sheikh Abdullah bin Zayed bin Sultan Al Nahvan, Minister of Foreian Affairs and International Cooperation, who represented the UAE Government, and Israeli Prime Minister Benjamin Netanyahu, hosted by US President Donald Trump in Washington DC.

The new law comes as part of the UAE's efforts to expand diplomatic and commercial cooperation with Israel, and by laying out a roadmap towards launching joint cooperation for bilateral relations on various

With the signing of this law, individuals and companies in the UAE may enter into agreements with bodies or individuals

residing in Israel or belonging to it by their nationality, in terms of commercial, financial operations, or any other dealings of any nature.

UAE becomes 1st Arab country to grant paternity leave in private sector

PRESIDENT His Highness Sheikh Khalifa bin Zaved Al Nahvan approved a new amendment to the UAE labour law, granting private sector employees paid paternity leave.

The UAE becomes the first country in the

Arab world to have implemented the policy. With this, male parents working in the private sector can take a five-day paid paternity leave-must be taken within six months of the birth of their newborn. The decree aims to further cement family

cohesion and stability, enhance UAE's position and competitiveness in the field of gender balance, and encourage young talents to work in the private sector. At present, female employees of the private sector get a 45-day maternity leave.

UAE Cabinet launches national vaccination policy

CHAIRED by His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice President and Prime Minister of the UAF and Ruler of Dubai, the UAE Cabinet approved the National Policy on Vaccinations, a multi-sectoral national framework for combatting communicable diseases and reducing their risks to individuals and society.

The Policy will act as a coordination framework for all parties involved in the immunisation field, in order to support the health system in the country and enhance the efficiency of provided services.

It also aims to bring together the non-aovernmental sector and community members to support the UAE's fight against communicable diseases by promoting a healthy lifestyle, as well as ensuring the delivery of the best quality

UAE offers full scholarships for children of healthcare workers

The Comprehensive Strategy for People of Determination includes 30 initiatives to be implemented over five years to create an inclusive environment and give People of Determination equal access to rights, services and opportunities.

It will be implemented by six working

teams, including: (1) Health and rehabilitation team led by the Department of Health; (2) Education team led by the Department of Education and Knowledge; (3) Employment team led by the Human Resources Authority; (4) Social Care team led by Zayed Higher Organisation for People of Determination; (5) Accessibility team led by the Department of Municipalities and Transport; (6) Enablers team led by the Department of Community Development.

These teams are tasked to address People of Determination's needs at all stages of life, including health rehabilitation, education, employment social care and social security, as well as social engagement, sports, culture and tourism.

UAE Cabinet issues resolution on mandatory installation of home fire detectors

UNDER the chairmanship of His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice President and Prime Minister of the UAE and Ruler of Dubai. the UAE has approved a resolution that obliges residential homeowners to install fire detectors and link them to the civil defence e-system.

The Ministry of Interior, through the Civil Defence Departments, was tasked to carry out the provisions of the new resolution and cooperate with all concerned parties to facilitate implementation procedures at all levels.

The mandatory policy will be applied to all existing residences or those that are still under or for construction.

The federal or local government

with issuing licences for the construction of residential homes are directed to ensure that fire detectors are installed in houses and the owner has subscribed to the e-system, before aranting a completion/ compliance certificate. The federal and local these devices in homes for people with limited income.

Owners of existing homes are given a period of up to three years to comply.

He said that regional and international challenges, along with the current situation across the world had led to changes in crime patterns and methods. THE UAE chaired the 36th meeting of the Directors General of Traffic in GCC countries, held remotely and discussed ways to enhance cooperation in implementing strategies and plans for better traffic safety.

Brigadier Engr Hussain Ahmed Al Harthy, Deputy Chairman of the Federal Traffic Council at the Ministry of Interior, who also stood as head of the UAE delegation during the meeting, welcomed the leaders and members of the participating delegations. Abu Dhabi Police implement new vehicle impounding law



ABU Dhabi Police have beaun implementing Law No. 5 of 2020 regarding the impounding of vehicles in the emirate starting September 9, 2020.

Brigadier Suhail Saeed Al Khaili, Director of the Central Operations Sector at Abu Dhabi Police, said the vehicle impounding law is consistent with the Federal Traffic Law, and that it is being implemented following thorough studies of accident and traffic violation statistics in the emirate. These studies were undertaken with the aim of enhancing traffic safety and reducing accidents, given the increase in the number of vehicles, he said.

Al Khaili added that the Traffic and Patrols Directorate of Abu Dhabi Police studied the most serious accident-causina

vehicle.

BRIGADIER Ahmed Abdullah Al Shehhi, Deputy Director of the Central Operations Sector at Abu Dhabi Police, stated that the police force is working on studying the gradual increase of penalties to control violators on the roads.

Deterrent measures are necessary to enhance traffic safety and curb accidents, said Al Shehhi, stressing the need to spread awareness on safe traffic behaviours to protect road users from death and injuries. He affirmed Abu Dhabi Police's



violations in order to deter reckless motorists through strict penalties. Under Law No. 5 of 2020, fines were increased in order to decrease traffic accidents and road deaths in Abu Dhabi, he said. Outlining the types of violations that would cause vehicles to be impounded as well as the corresponding penalties, Al Khaili said that motorists must pay a fine of up to Dhs50,000 for deliberately colliding with a police patrol vehicle or causing damage to it, and they would also have to pay for the cost of repairing the police

Motorists would also be fined for driving a vehicle with fake, hidden or altered plate numbers. Al Khaili said that motorists must pay traffic fines in full if their value exceeded Dhs7,000. Other penalties for

rash drivina are:

- A fine up to Dhs50,000 in case a
- motorist drives in a way that endangers his own life or the lives of others, or their safety and security;
- Withdrawal of a driver's licence for 6 months, along with a fine, in case the driver jumps a red light;
- A fine up to Dhs10,000 for changing a vehicle's engine or base (chassis) without a permit:
- A fine up to Dhs5,000 for causing an accident by speeding, sudden swerving, failure to leave enough distance between vehicles, not giving priority to pedestrians, and if a child under 10 years of age sits in the front seat, when the speed limit exceeds 60 kmph.

Abu Dhabi Police, in coordination with the Department of Municipalities and Transport, and the Abu Dhabi Waste Management Centre (Tadweer), seized 1.5 tonnes of niswar, a banned tobacco product, from a secret lab inside an unlicensed factory in the emirate. Four men arrested in the raid were referred to the public prosecution. All raw materials and equipment found in the lab were also seized and will be destroyed.



The rapid response of police and paramedics, who arrived within 3 minutes, prevented a blazing car from exploding and injuring nearby people. The car was being driven by a young individual at a high speed when it hit the sidewalk and flipped. The driver and the car's male passenger were able to get out of the vehicle before it was engulfed by the fire.



A Dhs2 million bribe boomeranged on a drug peddler after the Dubai Court of First Instance ordered him to pay the same amount in penalty for attempting to buy off an airport police officer. The 30-year-old Asian man was apprehended at the Dubai International Airport in October 2019. He will be deported after serving his jail term.



Sharjah Police busted an 11-member gang that stole 662 laptops worth Dhs2.4 million from the warehouse of a trading company. The theft was executed in a meticulous manner, without leaving a single fingerprint. They cut all CCTV connections and stole its digital storage. But intensive work by the Criminal Investigation Department of Sharjah Police led to the arrest of the suspects, and the police were able to recover all the stolen devices.







The historic Abraham Accord received full support from countries around the world, including Hungary, Greece, Germany, Japan, Costa Rica, Ethiopia, Bahrain, France, Belgium, India, Italy, Oman, Japan, Austria, Britain, along with Egypt and Jordan, the two countries that had normalised ties with Israel decades ago.

United Nations Secretary General Antonio Guterres stated that the joint announcement by the UAE, US, and Israel, effectively suspending Israeli annexation of several territories in Palestine, was a fulfilment of its call for peace in the said area. "[The agreement] will create an opportunity for Israeli and Palestinian leaders to re-engage in meaningful negotiations that will realise a twostate solution, in line with relevant UN



resolutions, international law and bilateral agreements," said Guterres.

Stéphane Dujarric, Spokesman for the UN Secretary General, affirmed that the UN would support efforts to promote peaceful dialogues. "Peace in the Middle East is more important than ever as the region confronts the grave threats of COVID-19 and radicalisation. The Secretary General will continue to work with all sides to open further possibilities for dialogue, peace and stability," said Dujarric.

The Global Council for Tolerance and Peace stated that the UAE had

achieved a more peaceful future for the following generations. "In the name of the Council and all its members and partners, we congratulate His Highness Sheikh Mohamed bin Zayed Al Nahyan, Crown Prince of Abu Dhabi and Deputy Supreme Commander of the UAE Armed Forces, for this historic diplomatic milestone, which will chart a more secure and peaceful future for the people of the world, and realise development, prosperity, and a decent life for the whole humanity," said Ahmad bin Mohammad Aljarwan, President of the Global Council for Tolerance and Peace. Dr Mohammed Matar Salem Al Kaabi, Chairman of the General Authority of Islamic Affairs and Endowments, said that this was a heartfelt gesture of the UAE's spirit that promoted love and peace in the world. He said, "The UAE has translated words into action by announcing the peace accord with Israel, in exchange for suspending the annexation of swathes of the Palestinian territories and implementing the two-state solution, according to relevant international laws and the Arab Peace Initiative, as well as permitting Muslims to pray in the Al-Aqsa Mosque and promote peace in the entire region."

COMMENCING COOPERATION

In the days after the accord was announced in August, the UAE and Israel began engaging in talks across different growth areas. They are as follows:

INVESTMENT: The Abu Dhabi Investment Office (ADIO) and Invest in Israel began discussions on how Israeli firms can tap the UAE's vibrant global business ecosystem. There was an initial virtual meeting between Ziva Eger, Chief Executive of Invest in Israel, and Monira Hisham Al-Kuttab, who leads ADIO's international promotional activity. Israel also pledged help from its ecosystem, providing fresh insights across sectors such as agricultural technology, energy, life sciences, and clean technology.

HEALTH: The two nations have pledged to face the COVID-19 pandemic together by strengthening their cooperation in medical research and pharmaceuticals. HE Abdul Rahman bin Mohammad AI Owais, UAE Minister of Health and Prevention (MoHaP) and Minister of State for Federal National Council Affairs, had a telephone call with Israeli Minister of Health Yuli Edelstein, discussing partnerships on vaccine trials, and treatment for the novel coronavirus disease.

DEFENCE: A phone call between HE Mohammed bin Ahmad Al Bawardi, UAE Minister of State for Defence Affairs, and Benny Gantz, Defence Minister of Israel, affirmed the bilateral commitment to enhancing regional security and safety.





FOOD AND WATER SECURITY: One of the top priorities of countries these days is achieving food and water security. Following the peace agreement, HE Mariam Al Mheiri, UAE Minister of State for Food and Water Security, and Alon Schuster, Minister of Agriculture and Rural Development of Israel, held a virtual meeting, pledging collaboration in areas such as aquaculture, agricultural technology, research and development, and related fields.



BUSINESS: One of the landmark achievements was the launch of the first Israel operations by a UAE-based business organisation. The company is Abu Dhabi's Group 42 (G42), a leading Artificial Intelligence and cloud computing firm, which has established a wholly-owned subsidiary in Israel, enabling further collaboration in technology, research and development.



FOREIGN AFFAIRS: HE Dr Anwar Gargash, UAE Minister of State for Foreign Affairs, has reviewed prospects for consolidating bilateral cooperation with Meir Ben-Shabbat, National Security Adviser and Head of the Israeli National Security Council. Top diplomats from the UAE and Israel discussed the development of strategic ties and reviewed regional and international developments of concern.

THE TREASURE OF CONTENTMENT **IS NOT EASY TO ATTAIN**

As we have seen during the pandemic and its economic fallout, it is hard to uplift one's spirits when one's life is weighed down by penury

rue richness is the richness of the soul" – this phrase has been repeated to us since childhood. While we were in primary school, our teachers would try to convince us that money was not everything. We grew up memorising this saying, and we would also bear in mind, that "contentment is a treasure that never perishes".

However, as the years pass, the innocence of our childhood begins to dwindle away. We face the demands of life and our

obligations towards our work and family. We recalculate things, trying to balance the ideals we were brought up on and the urgency of life's demands upon us.

I read a few days ago that MacKenzie Scott, the ex-wife of Amazon's CEO Jeff Bezos, the richest man in the world, had topped the list of the world's richest women with a fortune of \$68 billion (Dhs249.56bn), surpassing the \$66.8bn wealth of Françoise Bettencourt Meyers, the heir to L'Oreal who manages 33% of the world's largest cosmetics company.

I expected that Scott had earned this fortune in a field such as oil trade and other professions that few people are good at. Instead, I discovered that this

wealth was the result of her divorce settlement from Bezos. Now, she ranks No. 12 on the global rich list, after Bill Gates of Microsoft, and Elon Musk of Tesla, and Mark Zuckerberg of Facebook

Is it true that richness is the richness of the soul, and that contentment is the greatest treasure, just like what we learned from our teachers in school?

Ideally and morally, this is correct and unquestionable. In practical terms, some see it as preferable if the richness of the soul comes with the richness of the pocket. This is theoretically

acceptable, but is hard to achieve.

Statistics reveal that rich people get richer and the poor get poorer. This does not apply to individuals alone, but also to countries, according to the book Capital in the Twenty-First Century by the French economist Thomas Piketty. The book is based on research that Piketty and several other economists conducted over a decade, digging deep into the details of historical changes that have occurred around income and

wealth.

In practical terms, some see it as preferable if the richness of the soul comes with the richness of the pocket. This is theoretically acceptable but is hard to achieve.

The worldwide economic contraction in the recent months, the travel restrictions. the huge losses incurred by major companies in most business sectors, the bankruptcy of small business owners, all as a result of the spread of COVID-19, make us reconsider many theories that were in our lives before the novel coronavirus came along. Empty bank accounts and safes put pressure not only on our pockets, but also on our nerves. And when the nerves are exposed to this tremendous pressure, our memories may become fuzzy and we may forget the ideas that we believed in when we were young. Going back to what we started with,

and to Scott, who is at the top of the list of the world's richest women, we remember other sayings that we learned while growing up. One such saying was that "Life is all about destiny" - and we see that nothing stands in the way of destiny when a person who has one raffle ticket wins the draw, and the one who had a thousand vouchers won nothing.

It is true that contentment is a treasure, but it may perish for some when the troubles of life are too much for a person to bear. The important thing here is to be convinced that true richness is the richness of the soul, as we were taught in school.

he COVID-19 crisis brings with it a vital lesson: each country needs to work on increasing its population's immunity through a strategic programme that's proactive and not reactive. September 2020 has been a very eventful month in the worldwide fight against this pandemic, especially with regard to finding a vaccine, and the UAE has played a stellar part in it.

On September 14, in a landmark announcement, the UAE government authorised the emergency use of the COVID-19 vaccine, revealing that the vaccine caused no complications for individuals with chronic diseases.

HE Dr Abdul Rahman bin Mohammad bin Nasser Al Owais, Minister of Health

and Prevention, and Minister of State for Federal National Council Affairs, announced that people authorised to take the COVID-19 vaccine for emergency purposes include nurses, doctors, and other medical frontliners, whose very nature of work put them at a highest risk of contracting the viral disease.

"The vaccine would be available for first-line-of-defense heroes, who are most at risk of catching COVID-19, protecting them from any danger that they may be exposed to due to the nature of their work," Dr Al Owais said. "This emergency use of the vaccine is completely compatible with the regulations and laws that allow a faster review of licensing procedures."

taking part in the vaccine trial. She said that this gave hope for the UAE's vaccine candidate for the novel coronavirus (aka SARS-CoV-2).

"This emergency approval of the vaccine was given upon meeting a set of criteria for this specific purpose and we are working closely with the vaccine's developers," Dr Al Kaabi said. "The evaluation was performed under a license for emergency and limited use, considering target groups, product characteristics, clinical studies data, and all relevant available scientific evidence." In addition, the UAE has reached 8

million COVID-19 swab tests, cementing



world to conduct sufficient tests per 1 million population.

Just a week before its announcement on vaccine authorisation, the UAE Cabinet, chaired by His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice President and Prime Minister of the UAE and Ruler of Dubai, launched a policy with tremendous foresight on public health. The country, which has one of the best records in enabling global cargo movement of medical kits; of repatriating people stranded due to the pandemic; of testing people for the novel coronavirus; and of attracting tens of thousands of vaccine trial volunteers, launched its National Policy on Vaccinations on September 7.







He added: "These steps are taken with the goal of preserving the lives of millions of people and providing health care for the infected."

The same day, Dr Nawal Al Kaabi, Head of the National Clinical Committee for Coronavirus and principal investigator for the Phase III of clinical trials of the COVID-19 vaccine, said that 1,000 out of the 31.000 trial volunteers in the UAE were individuals with chronic illnesses, and none of these 1,000 volunteers suffered from any complications after

a multi-sectoral national framework for combating communicable diseases and reducing their risks to individuals and society. The policy is essentially a battle plan not only for COVID-19 but also for anything that may come after it.

Also in September, the United Nations, speaking on behalf of the World Health Organisation (WHO), called upon the international community to come forward and raise \$35 billion (Dhs128.45bn) more for WHO's Access to COVID-19 Tools (Act) Accelerator. The Accelerator programme aims to provide for the production of 2 billion vaccine doses, 245 million treatments, and another 500 million tests to halt the spread of the viral disease. WHO needs \$38bn in the immediate term – a period of three months - to attain its goals.

The funding appeal, made by UN Secretary-General António Guterres in an online meeting, was followed by a

pledge by more than 30 heads of state and ministers to fully fund the programme. "We acknowledge the urgency of catalysing a step-change in political support and financing for the ACT-Accelerator in order to enable it to deliver on its mission of accelerating the discovery and deployment of new COVID-19 tools to all people, everywhere," they said in a statement.

UMBRELLA POLICY

The UAE Cabinet has affirmed to the public that it would leave no one behind through the approval of the National Policy on Vaccinations, which serves as an umbrella for pulling under it all kinds of resources and organisations that would work together on the COVID-19 vaccine, and then expand the scope of preventive health care. The plan is to bring together the non-governmental sector and community members to support the UAE's fight against communicable diseases, by promoting a healthy lifestyle; as well as ensuring the delivery of the best quality of vaccination services and preventive care nationwide.

One of the most important features of the National Policy on Vaccinations is providing equal opportunity for all to gain access not just to the COVID-19 vaccine, but to vaccination for other communicable diseases as well. The goal is to immunise the entire population of citizens and expats. The policy would also look into the quality and sustainability of all types of vaccines.

Alongside, the policy covers promoting a healthier lifestyle amongst the public; generating awareness on the importance of vaccines; supporting research and innovation in vaccine development and



health care; and issuing guidelines on protecting public health during similar disease outbreaks and other related health emergencies.

GLOBAL COORDINATION

This is the first time that the whole world's researchers are working simultaneously and sharing knowledge generously to find a vaccine. Such coordination is not only desirable but indispensable, because the pandemic knows no borders

Thanks to all countries joining hands, the world has witnessed incredible speed in the development of the COVID-19 vaccine, from the launch of Phase I and II tests on limited numbers of individuals to Phase III tests on thousands of volunteers.

The fast-paced development of the COVID-19 vaccine is not without its risks, with many health scientists and experts voicing their concerns and calling upon pharmaceutical companies to be very careful during the human trials.

Statistically, if even one of 10,000 individual volunteers suffers from a serious adverse reaction, it could mean that if 1 billion individuals take the vaccine, there might be 100,000 or more individuals who would experience the same side effects.

History points out that it takes experts several years to measure if vaccines are truly effective for the targeted diseases, along with checking for possible side


effects. And while time is of the essence, haste and missteps may lead to disastrous consequences, similar to the polio vaccine that infected 40,000 children in a western country in 1955 instead of immunising them. However, despite safety and efficacy concerns, producing and procuring a vaccine against COVID-19 remains a top priority amongst governments worldwide, as the pandemic has crippled economies, tourism, businesses, and society as a whole.

ACCELERATED AVAILABILITY

The UAE has proven that it is one with humanity with the ongoing success of the world's first inactivated COVID-19 vaccine trials – 31,000 brave individuals in the country have joined thousands more around the world, taking the initiative of volunteering for clinical trials. If the vaccine is finally approved and goes into manufacturing, the volunteers would be amongst the first to receive it.

After the Phase III trials are done and pharmaceutical companies get the green light from the food and drug bureaus in their respective countries, the final step will be manufacturing enough of these vaccines to ensure global distribution.

The majority of the pharmaceutical companies target the end of 2020 for the initial availability of a vaccine, pledging to produce hundreds of millions of doses for the global population, with billions more to be produced in 2021.



COVID-19 VACCINE TRACKER

999 presents some of the vaccine candidates currently being tested across the globe:

SINOPHARM

NAME: None

ORIGINS: China's Sinopharm entered its initial clinical trials in April 2020. Its inactivated vaccine uses a dead virus to implant an immune cell memory. This induces an immune response against the novel coronavirus when it attempts to enter and affect the body. Experts state that the vaccine has several advantages, including mature production processes and wide-ranging protection backed by controllable, high quality standards.

STATUS: Following Sinopharm's successful Phase I and Il trials in China, a huge campaign was launched in the UAE to conduct the world's first inactivated COVID-19 vaccine trials, led by the Department of Health in Abu Dhabi, in partnership with Abu Dhabi's Artificial Intelligence and cloud computing company Group 42 (G42) and Sinopharm's China National Biotec Group (CNBG). The 31,000 volunteers in the UAE who received doses from July to August 2020 included two health officials – Sheikh Abdullah bin Mohammed Al Hamed, Chairman of the Abu Dhabi Department of Health (DoH), and Dr Jamal Al Kaabi, Acting Undersecretary at DoH – reinforcing the leadership's commitment.

"This achievement would not have been possible without the support of our wise leadership and its continuous support of scientific research in the health care sector. [The successful trial] will place our country at the forefront of global research efforts to confront this pandemic," said Al Hamed. At this point in time, all vaccinated UAE volunteers have completed more than 60 days since receiving the first

shot. All volunteers will continue to be monitored through telemedicine and face-to-face check-ups over the next year.

PFIZER-BIONTECH VACCINE NAME: BNT162b2

ORIGINS: The collaboration between Germany's BioNTech and global pharma major Pfizer since March 2020 has led to a vaccine candidate that is a type of messenger Ribonucleic acid (mRNA). It stimulates cells within the body to produce viral proteins that are recognisable by the immune system. With a small part of the genetic code of the SARS-CoV-2 spike protein, the mRNA helps generate an immune system response against the virus, thereby combating COVID-19.

STATUS: To date, Pfizer and BioNTech have over 120 clinical trial sites spread over 3 countries, with over 25,000 individuals enrolled for the vaccine programme. Pfizer and BioNTech plan to seek regulatory review in the US and Europe respectively in October 2020, to obtain approvals from the authorities. If approved this month, they target producing over 100 million doses before the end of 2020, scaling up to over 1.3 billion doses by the end of 2021.

ASTRAZENECA-OXFORD VACCINE NAME: AZD1222 / ChAdOx1 nCoV-19

ORIGINS: As announced in April 2020, AstraZeneca and the University of Oxford teamed up to create their own version of the COVID-19 vaccine, called 'AZD1222'. This vaccine uses a replication-deficient chimpanzee viral vector based on a weakened version of a common cold virus (adenovirus) that causes infections in chimpanzees and contains the genetic material of the SARS-CoV-2 virus spike protein. After vaccination, the surface spike protein is produced, priming the immune system to attack the SARS-CoV-2 virus if it later infects the body.

STATUS: Preliminary results from the trials of AZD1222 showed a strong immune response with increased antibodies and responses from T-cells with reported minor side effects, including fatigue and headache.

Trials have resumed in the United Kingdom after two voluntary pauses, when two of their volunteers suffered a suspected serious reaction in unrelated incidents. AstraZeneca and University of Oxford plan to produce at least 3 billion doses.

GAMALEYA NATIONAL CENTRE OF EPIDEMIOLOGY AND MICROBIOLOGY NAME: Sputnik V

ORIGINS: Building upon over a century of leading the world in medical research, the Gamaleya National Centre of Epidemiology and Microbiology in Russia has produced the world's first registered COVID-19 vaccine. It is named 'Sputnik V' after Russia's successful launch of the first space satellite in 1957.

The Sputnik V vaccine works through adenovirus vectors, which are vehicles that can induce a genetic material from another virus into a cell. The gene from adenovirus, which causes the infection, is removed, while a gene with the code of a protein from another virus spike is inserted, thereby helping the immune system generate antibodies against the novel coronavirus disease. Russian scientists developed

MODERNA THERAPEUTICS NAME: mRNA-1273

ORIGINS: Moderna, a biotech company based in Massachusetts, United States, has collaborated with the National Institutes of Health to create a vaccine candidate that relies on injecting harmless parts (mRNA) of the coronavirus into human cells. The process helps train the immune system to recognise the presence of the virus.

STATUS: Moderna's mRNA-1273 is currently in Phase III of trials. Preliminary findings show that healthy volunteers, even the elderly ones, produced sufficient amount of coronavirus antibodies, along with a reaction from T-cells, which is another part of the human body's immunity response.

The pharmaceutical company aims to deliver 500 million doses per year from 2021 as part of its deal with Swiss manufacturer Lonza, which will ramp up production to 1 billion doses per year.

STATUS: Russian President Vladimir Putin approved the said vaccine on August 11, 2020, revealing that one of his daughters had received the vaccine and was feeling well after getting sick during the first few days.

Sputnik V is funded by the Russian Direct Investment Fund and is being eyed to produce less than 1 million doses by the end of 2020 after Phase III trials in a number of countries. Mass production of Sputnik V is being eyed to start in March-April 2021.

CANSINO BIOLOGICS NAME: AD5-NCOV

ORIGINS: One of China's vaccine candidates involves the use of a weakened version of the adenovirus as a vehicle to introduce the spike protein of SARS-CoV-2 to the body. Preliminary results published in *The Lancet* state that the vaccine produced "significant immune responses" across a majority of the vaccine recipients from a single dose.

STATUS: The vaccine was in Phase II of its trials when the Chinese government approved its use, exclusively for the military, for one year only from June 25, 2020. In essence, CanSino was noted as one of the first companies in the world to receive limited approval to use the vaccine for humans. As of August 15, 2020, Petrovax, a biopharmaceutical company in Russia, revealed that it had launched Ad5-nCoV's Phase III clinical trials.



This is one of the questions faced by parents who do not have the power to control what happens on social media. Is there a way out? This is what we hope, although it is one of our biggest concerns.

PEDESTRIAN CROSSINGS EXIST FOR A REASON: TO KEEP PEDESTRIANS ALIVE. WITH MORE PEOPLE COMING OUT AFTER THE EASING OF COVID-19 RESTRICTIONS, 999 REMINDS ALL ABOUT THE LIFE-SAVING ZEBRA CROSSING -AND TAKES A PEEK INTO JAYWALKERS' MIND

ne late evening in September 2020, a 28-year-old Asian man in Ras Al Khaimah already had at the back of his mind — just as many of us do — the perils of crossing a road at an undesignated area. Still, he hurriedly crossed a part of Al Wakalat Road without the universally familiar zebra stripes for pedestrians. Before reaching the other side of the road, he was hit by a car. The collision killed the pedestrian on the spot; he would have lived had he spent a few more minutes on finding a designated area for crossing.

The accident was reported around 10:15pm, a time when it would have been difficult for the car driver to spot anyone running across the street. Police patrols and paramedics arrived in the shortest possible time, but they couldn't revive the man hit by the vehicle. "The body was shifted to the

morgue and the accident file was referred to the authorities concerned for legal procedures," said Brigadier Ahmad Al Sam Al Nagbi, Director of the Traffic and Patrols Department of RAK Police.

Talking to the media about the incident, the officer repeated a warning that the police give to people throughout the year. He said, "[Abide by] the consistent reminder of the UAE police forces to everyone, cross at a designated area only. Always bear in mind that one wrong step at the wrong place can be deadly. All pedestrians should ensure that the road is clear before crossing."

This kind of news is the last thing that the authorities want to hear in the midst of tackling a pandemic. Following the easing of mobility restrictions related to COVID-19, more and more people are stepping out of their house and moving around the cities.

When the UAE government has gone to such lengths to keep people alive and well during a global crisis, fatal accidents caused by jaywalking are amongst the most undesirable things.

While people generally acknowledge the dangers of bad driving, fewer people are ready to concede that jaywalking can be just as much a reason for road deaths. The result is also a pandemic of grief, as more than 270,000 pedestrians lose their lives on the world's roads every year, according to the World Health Organisation. This includes



jaywalking-due to lack of safe zebra crossing or unsafe behaviour of pedestrians.

"A jaywalker does not accept the reality that the human body is more vulnerable than metal during a collision," said Major General Eng Expert Mohammad Saif Al Zafeen,

Dubai Police Assistant Commander-in-Chief, and Chairman of the Federal Traffic Council, back in 2018. He said that a person hit by a car moving at 30kmph has a 10 per cent risk of dying, but if that car is moving at 64kmph, then the risk of dying is nearly 90 per cent. In other words, the greater the speed of the vehicle hitting the pedestrian, the bigger the impact, and the higher the risk of that pedestrian's death.

Abu Dhabi Police said that 48,000 people had been fined or detained in 2019 for ignoring the zebra crossing and crossing roads at undesignated places. Most of the people penalised were those who dodged speeding cars and blindly raced from one side of the road to the other. As for the other emirates, the statistics vary, but the problem of the careless pedestrian remains.

The grim fact is that most of the run-over cases in the UAE were entirely avoidable -they occurred due to jaywalking or motorists failing to give priority to pedestrians. It was such a serious matter that, when new regulations came into effect on July 1, 2017, amending the Federal Traffic Law No. 21 of 1995, the fine for jaywalking was doubled from Dhs200 to Dhs400.

The Ministry of Interior's Vision 2021 is to place the UAE on top of the list of safest countries in the world, by reducing traffic

fatality rates to 3 per 100,000 people by the year 2021. To achieve this target, authorities in the various emirates are laying a strong emphasis on responsible pedestrian behaviour.

FOLLOW THE 'SAFETY PATH'

Now that the foggy days of cooler months are almost upon us — the UAE's National Centre of Meteorology issued a fog warning on September 19 — the country's police forces are ringing the alarm bells for jaywalkers. Through an awareness initiative to sensitise pedestrians against the dangers of the J-habit, Abu Dhabi Police launched in September 2020 a very timely campaign called the 'Safety Path', which calls upon residents to only use footbridges, tunnels, and zebras, and to follow the traffic lights at intersections when crossing the streets. "Traffic police will keep a close eye

on jaywalkers and will maintain zero tolerance against offenders. A number of pedestrians ignore traffic lights and the traffic when they cross the roads, exposing themselves and others to the risk of being run over," said Abu Dhabi Police.

The police force added that the goal of reduced road fatalities could certainly be achieved at a much faster rate, if only people would sincerely abide by road rules. From October until the end of winter, pedestrians are warned that the number of fatalities rises amongst jaywalkers, as drivers have difficulty spotting them through the fog or at night. It has also been observed that many people cross the road at traffic signals even if the light remains red. The police forces are emphasising that everyone needs to follow traffic signals at intersections at all times.





NEW TECHNOLOGY, PROJECTS

On the subject of jaywalkers fined or detained in 2019, Abu Dhabi Police said that aside from traffic patrols' vigilance, the 'catch' was also the direct result of a new traffic radar that could detect people darting through vehicles.

The new smart system of Abu Dhabi Police, called 'Hather', is equipped with two cameras: one for the vehicles that are approaching the zebra crossing; another one for pedestrians, to detect jaywalkers. The camera pointed at the vehicles monitors licence plates; the other camera captures visuals of people for identification.

Dubai Police have also adopted a smart controller that isn't any old radar. Operated remotely by officers, using an app


on their smartphones, its features include high-resolution imagery that can catch people queue-jumping, speeding and jaywalking, amongst others.

In Shariah, four footbridges in some of the busiest districts of the emirate were unveiled in August 2020 by the Sharjah Urban Planning Council. These pedestrian bridges, built at a cost of Dhs100 million, were constructed to prevent jaywalking, and ultimately to protect lives. The bridges are located in King Faisal Street, King Abdulaziz Street, Al Ittihad Street, and Al Nahda Road. They are complete with overhead shades; have a clean, modern look; and are well lit at night.

WALK SAFELY NOW, CHILD

An 11-year-old Indian boy in Dubai had his request granted by the Roads and Transport Authority (RTA) this year. His request: to designate a pedestrian crossing in his locality, which has three schools.

Nehan Naseem Ali sent an e-mail to the RTA, telling them about the difficulty of little children like him as well as their parents, who admittedly braved fast

When the zebra crossing was implemented, it was a huge relief for these parents and their young children. "It's really a wish come true for all the residents in this area, especially the children who go to school," Ali said, conveying his thanks to RTA.

Asked about how he thought of suggesting this idea to the RTA, the boy said, "I have always seen the UAE rulers encouraging youngsters and their innovative ideas. They have motivated little children with small gestures like waving their hands or giving the children a smile."

Asian expat shared one instance from 2019 when he was caught jaywalking by a plainclothes police officer. Showing the ticket issued to him bearing a Dhs400 fine, Alex (name withheld) said, "I happened to be running late for work that day. It would only take me less than a minute to walk to the nearest zebra crossing, but for some reason, I chose to cross in front of our accommodation building.

"I did not realise that it would also cost me my first fine in six years of stay in the country. A plainclothes officer approached me and showed me his police badge. It turned out that he was an undercover police patroller who was tasked to spot iavwalkers."

The police officer took Alex's Emirates ID and gave him a ticket. Alex was directed to settle the fine at the police station so he could take the ID card back. "Never will I do that J-habit again, because it was

EXCUSES FOR THE TRAFFIC CHEAT

Jaywalking is a practice of people trying to cheat in the traffic by quickly cutting across a road when they shouldn't and from where they shouldn't. Meanwhile, behind the wheel, a motorist is constantly processing a range of information all at once - speed, other cars, the condition of the road, distance. The motorist does not expect the pedestrian to suddenly appear out of nowhere and get in the vehicle's way.

The common excuse of jaywalkers is that they're in a hurry and are trying to save a little time — therefore, they avoid the inconvenience of finding the nearest designated spot to cross the road. Talking to rule-breakers, 999 has uncovered what's in their mind:

"ZEBRA CROSSINGS ARE TOO FAR FROM OUR PLACE"

This is the most common answer that 999 got from pedestrians. They said that having to walk the distance from the doorstep to the designated place to cross the road drives them to jaywalk. Others said that they hesitate to use overbridges, citing the difficulty in climbing the steps as an excuse.

"NOT THINKING OF RISK WHEN IN A HURRY"

Some people said that they no longer think of the perils of jaywalking when they were in a hurry, especially when they are already running late for work or an appointment.

"RED TRAFFIC LIGHT TAKES TIME TO CHANGE" A number of pedestrians look at the traffic and do a quick mental math that tells them that they can trot or

sprint across the road. According to them, the red traffic light, in most cases, took up too much of their time, and they didn't think it was necessary to leave home early or plan their day better.

4 "I ONLY FOLLOW THE OTHER PEDESTRIANS" This kind of pedestrian is dictated by humanity's

oldest survival instinct: herd behaviour. Sometime during the wait, somebody in the crowd decides that there's enough distance between the cars for them to sprint across. Once the 'leader' sets off, the other pedestrians follow.

"NO DRIVER WOULD WANT TO KILL SOMEONE" 5 Several jaywalkers are confident that drivers would

be afraid to run over or kill a pedestrian, and that all drivers would stop for anyone crossing the road. They are also convinced that the responsibility of their lives is on the motorist.

n the early months of the COVID-19 pandemic, as human activity came to a standstill globally, planet Earth rested for a while and pollution levels plummeted. But by the time this year rolled into the second half, the fallout of the pandemic in the environment became clear on the seabed and shorelines.

A face with a protective mask on – to keep out the novel coronavirus – is now the most common sight around the world. People in many countries are using disposable surgical masks (made from lightweight synthetic fabric) for what they believe is added protection. That's all very well, but a significant number of these disposable mask wearers aren't so considerate towards nature and seem to care little about protection for the environment.

These surgical masks are often discarded irresponsibly and end up in the sea, adding variety to the existing pile of man-made trash on the seabed and in the sea waters. Thousands of masks, along with latex gloves and hand sanitiser bottles, are polluting the marine environment around the world. Laurent Lombard, founder of the French non-profit group Opération Mer Propre (Operation Clean Sea), wrote on social media that "soon we'll run the risk of having more masks than jellyfish in the Mediterranean".

VISUAL EVIDENCE

As per estimates of the World Health Organisation (WHO), 89 million medical masks are needed globally every month while the coronavirus pandemic lasts. To give you an overview of the humongous scale of these face masks, this lot can cover the whole Arabian Gulf more than 11 times:

Stokes and his team regularly visit that island, carrying out plastic pollution research and looking for clues to the origin of water pollution in the area. On that visit in March, the team easily noticed one item: discarded face masks, many of them, in the water bodies. He said, "Over time, the team has seen the odd mask here and there; however, this time

TIP OF THE ICEBERG

The humble face mask has become one of the most sought-after commodities during this pandemic. People of all ages are donning this piece of protective face covering, but its use reveals far more than it hides.

#WorldMaskWeek, a global movement to inspire more people to wear face coverings to help stop the spread of COVID-19, was celebrated in August. Besides, more and more companies are now manufacturing them, as a response to the initial global shortage of masks.

There's no doubt that face masks can limit the impact of the pandemic but

ARAB WORLD'S 1ST OF ITS KIND FACE MASK TESTING IN UAE

The UAE has rolled out in August a mechanism to test face masks which involves a layer of scientific analysis to ensure not only their quality, safety and efficiency, but also their heavy metal contents.

High content of heavy metals such as lead and mercury in face masks is harmful to both humans and the environment.

Considered the first-of-its-kind in the Arab world. the Consumer Products and Commodities Laboratory Section in Dubai Municipality's Dubai Central Laboratory (DCL) announced that it is now subjecting all cloth masks in the market to a 15-way test to ensure that the manufacturing is based on the latest carefully developed international standards.



This testing is now also being conducted in a few countries including South Korea, Thailand, China and France, The 15-way test includes analysis of the pH level, heavy metals and formaldehyde contents, air permeability, as well as color stability for wet and dry friction.

depending on the irresponsibility level of their wearers when disposing of the masks, these can lead to another human and animal health crisis.

Mask manufacturing and use will continue, and maybe increase, as economies keep slowly re-opening. So, the only way to avert an ecological disaster is for people to realise that their careless disposal of masks would eventually become a danger to themselves.

The mask-making business is certainly booming. According to the World

Economic Forum, the global market for disposable masks ballooned to \$75 billion (Dhs275.25bn) in the first quarter of 2020, and it is expected to grow at a rate of over 50 per cent for the next seven years.

At the start of the outbreak, US officials estimated that the country needed 300 million face masks to cope with COVID-19. Since then, a US-based manufacturer, which made 550 million masks in 2019, said that it would produce 2 billion masks in 2020 at its plants around the world. That's almost a 400 per cent increase year on year.

In France, 2 billion disposable masks have been ordered by the authorities as part of its measures to protect citizens. China's daily production of all types of masks had increased by more than 100 per cent, from

around 10 million to 115 million, by the end of February; production has expanded 12fold since the pandemic took hold. In the UAE, one supermarket alone said in March that it was sourcing 1.6 million face masks daily, on an average.

If even a fraction of these masks finds their way into the sea because of negligent humans, the word "disaster" simply couldn't cover the scale of the fallout.

EXTREMELY HARMFUL EFFECTS

Since they are lightweight, face masks could be carried by the wind from land and landfills, said Habiba Al Marashi, Chairperson of Emirates Environmental Group, a non-government entity focused on sustainability, speaking to the media. She added that most of these lightweight

masks would remain in the environment as pollutants. "The materials found in most PPE are non-biodegradable and oftentimes contain fibres such as microplastics that are extremely harmful to the environment," said Al Marashi, explaining that face masks are partially plastic, which could take hundreds of years to degrade. The responsibility, she said, lays heavily on the discipline of all segments of society.

As much as we want this pandemic to end and have a sense of normality restored, the environment must not be compromised due to our carelessness. It doesn't take a very keen eye to spot irresponsibly discarded face masks - when you do the shopping at a supermarket, chances are you'll see one discarded in the shopping cart itself. This usually blue-coloured PPE is also an eyesore at parking lots and on sandy beaches or shorelines. People just dump them everywhere without a thought for the health and safety of others, especially the street sweepers and sanitation workers.

POLICE HAVE AN EYE ON YOU The UAE Government has made face masks mandatory in all public places. What's worth praising is how the UAE law enforcement is strictly monitoring those who throw their used face masks on the road. Pedestrians caught doing this by patrol policemen face a hefty fine and other punishment.

In their ongoing initiative to spread a culture of safety amongst residents, Abu Dhabi Police and Ajman Police are urging the public to be responsible while disposing of their used PPE.

"Abu Dhabi Police are well aware of the hazardous health and environmental risks that such dumping acts can pose to the community as a whole," said Lt Colonel Mohammad Mubark Al Ghafli, Head of the Abu Dhabi Police health and safety committee. "Those who would be caught throwing used masks and gloves from their vehicles would get a fine of Dhs1,000 and 6 black points," he added. The correct way to dispose of a face





mask, Al Ghafli said, is to place it in a used bag and then put it in a dustbin. "People should also wash their hands after handling used masks," he stressed.

UAE'S INNOVATIVE FACE MASK

To address the global shortage of face masks and also curb the one-time use of this essential item, New York University (NYU) Abu Dhabi, in coordination with Mubadala Healthcare and Cleveland Clinic Abu Dhabi, has designed a hard-wearing face mask, similar to an N-95 mask, but one that can be reused after sterilisation.

"The idea is to do it locally, in the UAE," said Ramesh Jagannathan, Vice Provost for Innovation and Entrepreneurship and Managing Director of startAD, the NYU Abu Dhabi's innovation and entrepreneurship programme. "Right now, masks are disposable — you wear them and toss them out. Ours is better in terms of sustainability and cost effectiveness."

The 3D face masks are treated with heat in order to achieve a smooth surface, and then breathing filters are placed on the mask, straps are tightened, and a simple layer of recyclable, environment-friendly polyurethane is placed on its boundary. It is made of plastic, predominantly of tough Polylactic Acid (PLA), a biocompatible material that bio-degrades into Lactic Acid (LA). As the mask is recyclable, it also minimises pollution caused by waste. The mask is made of a soft material, with a disposable filter. It can be sterilised using UV light, heat, or chemical treatment.

HOW UAE TREATS COVID-19 WASTE

The UAE Government ensures only the best environmental practices in treating polluted waste, which now includes COVID-19 medical waste, such as singleuse PPE.

In Dubai, for example, the municipality is managing medical waste taken from public and private clinics, hospitals, health care centres, and laboratories, and then transporting that waste directly to the Jebel Ali Hazardous Waste Treatment Facility. There, the medical waste is treated on a daily basis, using a central treatment system. Since the start of the COVID-19 outbreak until the end of April 2020, this facility has treated more than

Eng Abdul Majeed Saifaie, Director of the Waste Management Department at Dubai Municipality, said, "All medical waste is dealt with technically, according to the highest levels of occupational health and safety, except that medical waste possibly contaminated with COVID-19 is sterilised

upon arrival at the facility directly, and have priority in treatment over other medical waste for disposal."

He added that all equipment, vehicles, and the entire facility were completely sterilised on a regular basis to avoid any infection amongst the staff. Now, all that we need to do, as laypersons, is dispose of our masks correctly.

TIPS TO DISPOSE OF MASKS PROPERLY

During the 23rd edition of the Emirates Recycling Awards held through a webinar in June, Habiba Al Marashi, Chairperson of Emirates Environmental Group, gave important tips on how people should dispose of the used face masks and other PPE items.

- · Commonly used PPE such as gloves and masks should be disposed of in a trash bin as soon as you remove them, to ensure that they do not end up elsewhere in the environment.
- After a shopping trip, remove your gloves immediately and discard them into the waste bins outside provided by the municipality.
- Do not mix PPE waste with recyclable waste. Practise separating your used gloves and masks from other common household waste when disposing of them.
- Although some disinfectant wipes are labelled as flushable, do not ٠ flush them down the toilet. This can cause clogging and hazardous backups and overflows to occur in the sewage system.
- Always wash your hands thoroughly before and after handling the • items.

igh finance and business have always been associated with men in C-level positions, their palpable presence seemingly reflecting their dominance in the sector. But there actually exists — on the sidelines — a massive and growing number of women showing just the same level of business acumen.

Contrary to popular belief, female entrepreneurs already have a vital role in the world economy and can contribute much more; their contribution is absolutely crucial to ensure global financial stability. According to data released by Harvard Business Review, women actually represent a growth market larger than China and India combined, possibly twice the size. Their participation in the global economy is also expected to increase worldwide GDP by \$28 trillion (Dhs103 trillion) in 2025, as per a report by the World Economic Forum (WEF).

Even in the Middle East, women have been surging forward at the business arena. According to Christina Struller, Vice President of Public Affairs for global logistics company United Parcel Service (UPS) in the Indian Subcontinent, Middle East and Africa (ISMEA), one in three start-ups in the region is founded or led by a woman — that's a higher percentage than in Silicon Valley, California, one of the global hubs of entrepreneurship.

"Today, one in three start-ups in the Middle East is founded or led by a woman – a higher percentage than in Silicon Valley. This number is expected to continue growing as women entrepreneurs leverage the Internet and turn to digital channels to enter the workforce and start their own businesses. URGENCY OF FINANCIAL INCLUSION

achieving greater heights in business. This is especially evident in terms of access to financial services, even as simple as banking.

Data from the non-for profit organisation Women's World Banking show of the 1.75 billion women across the globe who have bank accounts, 57 per cent (1 billion) are underbanked or underserved, and only 20 per cent (335 million) have active bank accounts. The organisation also cited that there is still about \$1.7 trillion (Dhs6.2 trillion) worth of unmet credit demand for women-owned Micro, Small & Medium Enterprises (MSME).

This only shows that there is still a huge need for empowering women around the world, according to Ruth Yu-Owen, Co-Founder of Connected Women. She said that women's inclusion in finance and entrepreneurship would bring about increased global productivity and revenue **Eight out of** 10 women are now involved in small businesses around the world. Women's World Banking Southeast Asia Advisory Lead Elwyn Sansius Panggabean stressed that closing the gender gap in product access across the retail banking sector could unlock at least \$50 billion (Dhs183.7 trillion) in additional annual revenue.

Analysis by the Goldman Sachs Global Markets Institute in October 2019 also noted that decreasing gender disparity in credit access could improve developing world growth rates by 1.1 per cent. With the socio-economic effects of

COVID-19, Panggabean added that gender equality in financial inclusion is needed now more than ever, especially as more and more women were setting up their enterprises and needed funding. "Eight out of 10 women are now involved in small businesses around the world. There is a growing number of women starting businesses in order to provide for their family, especially those whose spouses lost jobs [due to the pandemic]," he said, adding that 70 per cent of these small business owners were currently struggling with getting access to adequate finance.

WOMEN ARE GREAT BORROWERS

Ever wonder why, despite male professionals seemingly dominating the business sector, the wives and mothers are the ones tasked with managing the household budget? Apparently, they're

better at managing finances. Experts reveal that women have a better knack for monetary management, and that female-controlled finances increase welfare of the family.

According to the 2020 research released by Women's World Bankina. women manage to save on an average 10-15 per cent of their earnings despite low and often unpredictable incomes, although their inadequate access to financial instruments forces them to save in informal and unreliable ways.

Women were excellent borrowers as well, stressed Panggabean. The same report by the organisation stated that female borrowers had a very low rate of non-performing loans (NPLs) i.e. a loan that's close to being in default. "Some of our partners report to us that in terms of the NPL percentage of men and women, men have the higher rate," he said. "Hopefully, this indication can motivate financial institutions to focus on providing women more access to finance."

CHALLENGES THEY FACE

Women entrepreneurs encounter various hurdles, from inadequate financial support and lack of flexible career opportunities to cultural issues in several parts of the world.

Struller said that these challenges are the reason why only one out of five businesses in the export industry is led by a woman. "Women entrepreneurs face many barriers to finding resources to help them launch and grow successful businesses. These often prevent women from having the same opportunities as men to start and develop businesses," she said.



And then, there are the additional family responsibilities. The onset of COVID-19 and the work-from-home system put an extra burden on women, said Yu-Owen, pointing out that women entrepreneurs now also had to handle "online classes and elder care, while working from home".

TRENDS AND OPPORTUNITIES

COVID-19 has meant unique challenges for emerging markets, especially for women entrepreneurs. They have been impacted by the crisis in three key areas: health, economic, and social. However, there are also various opportunities that they can explore in this new normal.

One opportunity is fortified digitalisation in all aspects of business and finance. There are various analyses that show that this digital connection is integral



to bolstering companies, especially exports. According to the World Trade Organisation, there are now 97 per cent of Internet-enabled SMEs that are engaged in exporting. This is also the reason the pandemic has accelerated the shift to e-commerce, as stores have been forced to close their doors due to social distancing and containment measures.

"Digital trade strategies will be critical for women entrepreneurs' success. This is a worldwide trend, as illustrated by the projected \$596.8 billion (Dhs2.1 trillion) in year-over-year growth of the global e-commerce market," said Struller.

She added that while it is difficult for developing countries to get access to the Internet to facilitate orders and payment collection, once digital connectivity and the resulting tools are available, they could offer "leapfrog" opportunities for women's economic empowerment.

Yu-Owen also stressed upon the importance of advocating technology adoption in the transformed world, a reason the Connected Women community is designed to help its members digitally connect and work with each other. "Technology is a game-changer for women as it levels the playing field and opens up more opportunities. Our key advocacy is technology adoption for remote and flexible work," she added.

Panggabean was of the view that the pandemic would spur women into becoming full-fledged professionals, stressing that more women were now



entering the workforce to offset job losses in the family. However, even as digitisation of financial services is growing significantly, he saw women as less connected, less confident, and less prepared than men to use these services. "There remains a large gender digital divide. Women are 14 per cent less likely to own mobile phones, and 43 per cent less likely to engage online than their male counterparts," he said. This is why it was imperative for organisations and governments to support women in terms of increasing their digital and financial capabilities, he said.

He added that another trend that would arise from this crisis was renewed resilience amongst women. Since women are particularly vulnerable to economic shocks due to their inadequate access to finance, they'll become even tougher and more motivated to manage finances and save in the post-crisis era.

EMPOWERING INITIATIVES

Initiatives undertaken to close the gender gap in business and finance provide hope that the potential of women entrepreneurs would be unlocked, giving them the chances as men.

Women's World Banking, according to Panggabean, had been powering economies for four decades by implementing advocacy-led strategies to financially assist women, especially lowincome women, in emerging markets.

The institution has been increasing its activation and engagement for women, launching initiatives such as marketing and communications strategy for their business, assistance in operational procedures, and advocacy campaigns. "We know that bringing women to the forefront of the financial sector can reduce poverty, increase equality, and have long-lasting intergenerational effect. We provide security, prosperity, and empowerment to women," he said. Speaking of her organisation's support for female entrepreneurs, Struller cited the Women Exporters Programme, launched by UPS and the UPS Foundation as part of the company's efforts to promote diversity and inclusion. The organisation has also joined Women 20 (W20), the official

engagement group of G20, in order to "develop policy recommendations for governments and private sector, to help eliminate gender inequalities in areas of digital trade, finance, labour, and decision-makina".

Establishing partnerships across the globe is another initiative from UPS to support women. The company has already forged alliances with the International Trade Centre's SheTrades initiative. Dubai Exports. The World Bank's Women Entrepreneurs Finance Initiative (We-Fi) programme in the Middle East and North Africa, and WEConnect International. Struller said, "Those initiatives help connect women buyers and sellers in the global supply chain and provide trainings on how to expand their business in the international marketplace."

or around two years now, UAEbased expat Gie Drew, 60, has been celebrating what she describes as her "second chance" in life. The year 2001 began on a bleak note for her, as she was diagnosed with stage 1 breast cancer; till 2018, her ordeal went on, as the cancer returned and was in stage 3. She has come out stronger from her painful and occasionally dispiriting treatment, and now feels grateful and determined to spread the message of awareness about breast cancer.

Recalling the time when she got the first diagnosis, Drew said that she had never felt so depressed in her life — the upsetting news felt so unreal. "I was so upset the first time I was diagnosed, because I had very little understanding about breast cancer during that time," she said.

Her first surgery, called lumpectomy, was performed in the UK - that day washer birthday. Following the operation, she was diligent in taking care of herself, but faced the same ordeal once again as the cancer returned in a more advanced stage. "This has been the most painful experience that I've had to go through in my life. I nearly gave up, stopped eating and drinking because everything I would take, I'd just throw up," said Drew. "The most distressing moment I had was when



I started losing my hair." But she survived the killer disease and cherishes each day. Meanwhile, another breast cancer survivor Nanny Monteiro, 55, felt like she was detached from reality when she first found out in 2013 that she had breast cancer, especially since she didn't have any family history of the disease. "When the doctor told me I had cancer, it didn't sink in immediately. At that moment, I froze. I just couldn't believe I have it, as

we've never had anyone in our family who

had cancer," she said.

Drew and Monteiro are amongst the many women who have suffered from the grave effects of breast cancer - not just physically, but also emotionally and mentally. Breast cancer is a major public health concern in many countries, both rich and poor, impacting millions each year and causing the greatest number of cancer-related deaths amongst women globally.

The latest data released by the World Health Organisation (WHO) has revealed that breast cancer affects 2.1 million women in the world each year. In the UAE, the country's National Cancer Registry revealed their 2015 data that breast cancer, which recorded 113 deaths at that time, was the leading cause of cancer deaths.

Progress in lines of treatment has been tremendous, but what's equally important is awareness about what this type of cancer means; ways of early diagnosis, including self-inspection; and rebuilding life after surgery.

Since 1985, October has been observed as Breast Cancer Awareness Month. the result of the global goal to increase attention, highlight the importance of early screening and treatment, and support proper treatment. This annual campaign aims to broaden the discussion about this illness to stand in solidarity with patients, empower survivors, and advance research that could potentially save thousands of lives every year.

UNDERSTANDING BREAST CANCER

AILEEN VILLANUEVA

Similar to other forms of cancer, breast cancer is an illness wherein cells in the breast grow out of control. Aileen Villanueva, General Practitioner at Mediclinic AlNoor Hospital in Abu Dhabi and the chairperson of Shades of Pink Society, a non-government organisation that advocates breast cancer awareness in the UAE, told 999 that breast cancer could start from different parts of the breasts. It can begin in the ducts (that carry milk to the nipple), in the glands (that make breast milk), and in other tissues in the breast.



UNCONTROLLABLE RISK FACTORS GENETICS AND HEREDITARY RISKS

Dr Mai Sultan Al Jaber, Medical Director at Healthpoint, Abu Dhabi, said that individuals who had family members suffering from cancer are more likely to develop cancerous cells due to their genes, particularly the well-known gene mutations referred to as BRCA1 and BRCA2. Women with these genes, or those whose mother or sister was affected, are at a higher risk of breast and ovarian cancer.

2 AGE

In an interview with **999**, Dr Jemini Abraham Paul, Head of Specialist Obstetrics and Gynaecology department at NMC Medical Centre in Deira, said that the risk of breast cancer increases with age. The US Centers for Disease Control (CDC) said that most breast cancers are found in women aged 50 and above, while Yale Medicine said it occurs in men aged 60 to 70. This type of cancer is very rare in men, but the risk does exist, and so awareness amongst both genders is equally important. According to the US-based National Breast Cancer Foundation: "Less than 1 per cent of all breast cancer cases develop in men, and only one in a thousand men will ever be diagnosed with breast cancer."

PERIODS, PREGNANCIES, AND MENOPAUSAL FACTORS

Women who might have begun their periods early in life (as young as before 12 years old) or menopaused at an older age (as old as after 55) have increased risks

of developing breast cancer, according to Dr Paul.

"Also, women who had the first pregnancy after the age of 30, and those who never had a full-term pregnancy are at a higher risk of getting breast cancer," she said.

Not breast-feeding has also been shown to increase the risk.

PRE-EXISTING BREAST CONDITIONS

Experts have observed a trend that women who have had some other medical conditions in their breasts are also vulnerable to breast cancer, especially those diagnosed with lobular carcinoma in situ (LCIS) or atypical hyperplasia of the breast.

Having dense breast tissue also puts one more at risk of this disease, according to the US Centers for Disease Control




because it could mean more connective tissue than fatty tissue, making it hard to see tumours on a mammogram.

CONTROLLABLE RISK FACTORS SEDENTARY LIFESTYLE AND OBESITY

Dr Paul said that lifestyle adjustments, such as proper diet and regular exercise, play a crucial role in minimising the risk of cancerous cells in the body. She added that women who are not physically active and/or consumed too much unhealthy food and drinks, as well as those who are overweight or obese, have a higher risk of getting breast cancer.

"Physical inactivity is a well-established risk factor for several types of cancer. Several reasons have been proposed on how physical activity reduces breast cancer risk," she said.



ENVIRONMENTAL RISK FACTORS

The importance of pushing for a green society is truly evident on all fronts, even in preventing breast cancer. Experts say that being exposed to certain elements in the environment could increase the risk of cancer.

REPRODUCTIVE FACTORS

Dr Paul said that women who became pregnant after the age of 30, who chose not to breastfeed, and who never had a full-term pregnancy should watch out for early signs of the disease.

Smoking puts one at a much higher risk of not only lung cancer but also of breast cancer. The chemicals from tobacco can imbalance women's hormones, according to a 2017 study published in Breast Cancer Research, a respected international journal in this field. The study authors stressed that smoking significantly increases the risk of breast cancer, especially for those who began puffing during adolescence or had a family history of the disease.

SCREENING AND DETECTION

The importance of screening and early detection of breast cancer cannot be stressed enough - this is women's best weapon against the disease. Discovering breast cancer at an early stage of 0 to 1 leads to an almost 100 per cent rate of cure, according to experts. It's very important to know the warning



signs of breast cancer, and this can be done through self-examination or at screening centres.

"This is a national public health concern [but] many women wait until they experience symptoms before consulting with their doctor. Education and awareness are very important. Women need to know their family's medical history and their susceptibility to the disease, and they need to understand that, in many cases, symptoms of breast cancer will not appear until the disease has progressed to a more advanced stage. That's why regular screening is important," said Dr Suhaila Alameeri, Consultant Anatomic Pathologist at the National Reference Laboratory and member of the National Taskforce for the Breast and Cervical Cancer Screening Programme, speaking to the media.

Indeed, breast cancer patient Monteiro credits her survival to early detection, saying that she immediately went to the hospital when she discovered a lump in her left breast. "Early detection is




importance of getting checked once abnormalities are noticed in the breast. "My advice to my fellow survivors and to all the women and men out there is to screen themselves. It's very important to always self-exam your breast," she said.

DON'T BE 'TOO SCARED'

Apparently, not everyone can muster the courage to step into a hospital or clinic and get themselves checked — about 30 per cent of women in the UAE admitted that they would be "too scared" to visit a doctor if they suspect they have breast cancer, according to a YouGov survey in 2018. That's not going to help. Even if you're scared of undergoing tests right away, make sure to talk to a medical professional for information and advice on the next course of action.

"If you're nervous about getting a mammogram or other screening, that's understandable. I recommend having a general chat with your doctor first to discuss any health risks and to decide if

any tests need to be done," said Dr Nairah Rasul-Syed, Health Medical Director and Consultant in Family Medicine.

The survey, undertaken by global health insurance provider Aetna International, put its questions to 358 women in the UAE aged 18-60 years. Besides the "too scared" factor, it also found that 43 per cent of the respondents had never taken steps to check for breast cancer.

Misinformation is another hurdle. The study showed that 52 per cent of the women believed that wearing a tight brassiere could be a cause of breast cancer; 36 per cent believed that the



use of aerosols and deodorants could be contributing factors; and 13 per cent and 10 per cent, respectively, thought that the use of microwaves and mobile phones were linked to the illness.

The survey revealed that 40 per cent of the women were not aware whether cancer treatment in general was covered in their health insurance policy. Such data highlight the need to build breast cancer awareness in the UAE.

"[During] Breast Cancer Awareness Month, we urge people to think seriously about this, to look out for any signs and to check what their policy covers, especially if there is a history of cancer in the family," said David Healy, CEO of Europe, Middle East and Africa for Aetna International, following the survey. "We know that when breast cancer is detected early, and adequate diagnosis and treatments are available, it is a very curable condition."

LIFE-CHANGING CHALLENGE

Drew said that one reason she founded the Shades of Pink Society was because she understood a patient's ordeal. "Being diagnosed with breast cancer can be overwhelming, so it is important to seek help and support. Patients can do this by joining a support group like the Shades of Pink Society. I formed the organisation because as a survivor, I know how important it is to provide the help that patients need," she said.

About her own experience, she said, "It was a difficult struggle. And even now, every time I think about my fight with breast cancer, I can't help myself but cry."

The feared disease has changed her perspective. "Cancer taught me to appreciate everything and everyone in my life. I am so blessed for getting a second chance to live my life surrounded by my loving family and friends. I am stronger now," said Drew.

Monteiro said, "My message to other patients is: you're stronger than you think, never give up and always look at the bright side. With faith in God, prayers, love and support from family and friends, you will win the battle over cancer. You can defeat it."

UAE'S CANCER STUDIES

The UAE has always been committed to combating breast cancer. The leadership's goal is to reduce cancer mortality as part of its National Agenda and Vision 2021.



With this aim, the government calls upon everyone to get tested as early as possible. The country also promotes and invests in advanced cancer research and treatment. In June 2020, researchers from Gulf

Medical University (GMU), in collaboration with the National Cancer Institute (NCI) of the United States, created a novel compound that can inhibit the growth of cancer cells. In various laboratory testing procedures, these experts designed and chemically synthesised this compound, which has the ability to block the growth of several different types of cancer cells (e.g. leukaemia, breast cancer, and colon cancer cells) by inhibiting one of the enzymes implicated in the abnormal growth of cancer cells.

The study was led by Dr Ahmed Thabet Negmeldin, GMUS's Assistant Professor of Medicinal Chemistry, and Dr Ahmed Al-Abd, Associate Professor of Pharmacology.

YOU, TOO, CAN SPREAD HOPE

In the awareness drive against breast cancer, everyone has a part to play. Whether you're a fighter yourself or you know someone going through this disease, your role in advocating early detection and prevention measures is crucial

Emirati student Malath Al Ameri recognised at an early age of 16 her responsibility in promoting the fight against breast cancer. In the Pink Caravan

Ride (PCR) in Abu Dhabi, organised in March 2020 by the non-profit Friends of Cancer Patients (FOCP), the teenager pitched in as an equestrian volunteer she did so in the name of her mother, Mona Abdulrahman.

"My mom was diagnosed with stage 4 breast cancer, which made the treatment hard on both her and our family," said Malath. "If she had been detected earlier, the treatment process would have been easier on her. Getting regular screening tests is the most reliable way to find breast cancer early, and that's why I am here at the Pink Caravan Ride, to take this message far and wide to the community." She and several other equestrian breast cancer advocates mounted their horses and fanned out across Abu Dhabi, covering a distance of 14km.

REDUCING THE RISK

Over your lifetime, a lot of contributors can influence your risk of having breast cancer, and while you cannot change some factors, you can definitely make beneficial lifestyle choices. According to Dr Jemini Abraham Paul, Head of Specialist Obstetrics and Gynaecology department at NMC Medical Centre in Deira, these are some of the things you can do:

- · Maintain a healthy weight
- Keep an active lifestyle
- Eat several servings of vegetables and fruits per day

- · For those with a family history of breast cancer, consult your doctor about ways to lower vour risk





They journeyed through the Ministry of Foreign Affairs, Abu Dhabi Corniche, Marina Mall, Sheikh Zaved Grand Mosque, reaching Healthpoint, where they concluded their nationwide journey that had begun in Sharjah.

Malath's mother Mona expressed her deepest pride in her daughter, saying, "I call it the 'Hope Caravan' - it's a ride that saves lives, literally. People should be aware of breast cancer and the need to be checked regularly, not only for women but for men as well."

She added that her medical condition wouldn't let her be part of the Pink Caravan, so she was happy that her daughter took the march forward. "As a person who has undergone treatment. I know what breast cancer entails and the woes that come with it," she said. "That's why my daughter is on horseback; I want her to raise greater community awareness and share our story of cancer so that people take heed and get their screenings done on time."

Another equestrian volunteer, Mira Ahli, was herself a breast cancer survivor. "Every member of society should know how just a short amount of time spent on a checkup can potentially save lives, reduce the treatment burden and the hardships associated with it," said the 30-year-old.

She added, "You're never too young to be screened. Both men and women should not think twice or delay getting themselves checked, because diagnosing a disease early improves outcomes greatly. Our goal, through PCR, is to urge people to step forward and take action by visiting the free clinics for screening."

To this end, we urge more organisations to come forward and promote a stronger culture of corporate social responsibility in the UAE," said Dr Sawsan Al Madhi, Director General of FOCP and Head of the Pink Caravan Ride Medical and Awareness Committee.

The organisation provides programmes that help patients manage their stress as well as cancer awareness sessions, including monthly Zumba sessions, seminars on how to maximise their quality of life after cancer, and the annual 'Walk for breast cancer'

THE CURRENT GLOBAL SCENARIO HAS CHANGED THE WAY CONNECTIONS AND PROFESSIONAL ACTIVITIES ARE BEING CONDUCTED TODAY - THAT INCLUDES JOB INTERVIEWS. MAKE A MARK IN YOUR ONLINE INTERVIEW WITH THESE TIPS

fter some time searching for new career opportunities, you finally get a call for a job interview. Hooray! However, there's a catch: it will be done through a video call. How do you deal with it, knowing that your usual ways to impress a potential employer will be greatly restricted?

Body language matters a great deal in physical interviews, but in a video interview, it's not quite as effective. So, your strategy will need to be revised. This kind of scenario is becoming more and more of a







norm today, accelerated by the novel coronavirus disease (COVID-19) and the need for social distancing. Increased use of technology and lockdown measures have given rise to virtual meetings via Zoom and Teams, webinars, and the like. Gone are the days of walk-in interviews and dropping by unannounced to submit your CV. Almost everything now has to be done online, even job interviews.

So how to do you actually impress a potential employer through your computer screen? Check out these tips.



1 TEST YOUR INTERNET SPEED AND GADGETS WELL IN **ADVANCE**

The perfect recipe for a disastrous online job interview includes poor Internet speed and an inefficient tablet/computer/mobile phone. Wi-Fi or Internet connectivity is the very first thing you should assess to make sure you're set up for success. Take the time also to check your camera and microphone (if the image is grainy, or if there is an annoying echo coming from your mic) to make sure the interview goes through without a hiccup. Remember, these are your only weapons to propel yourself towards a real employment opportunity.

Don't do these checks just five minutes before the interview, or you could be stressed with all the last-minute hassles and you might even get late for the interview. Technical glitches during the interview also sends the wrong impression, as it can make the recruiter think you've come unprepared, or worse, not interested in the job enough to fix the problems prior to the online appointment.



PROFESSIONALISE YOUR HOME SETTING

Do you really want your online interviewer to see your messy bed and your piled-up laundry, with your latest Netflix binge visible in the background? Make sure you fix up the home setting in a professional manner, i.e. a tidy home office or desk, as well as a blank wall or a neat bookshelf behind you. An organised bookshelf creates an atmosphere of intelligence and interest in learning.

From this setting, eliminate all distractions like TV, radio, mobile phone, and noise from the outside. If you have pets, put them somewhere to prevent an unannounced appearance during your interview.

DRESS TO IMPRESS

Just because you're at home doesn't mean you can face your recruiter looking like you just rolled out of bed. Dressing formally for your online interview shows that you are serious about the position, and it can even exude confidence during the entire interview process.

Treat your online interview like it's an in-person interview. For men, this means polo, blazer, and chinos; and for women, this means dress or a blouse and a skirt. Make sure you put on makeup as well.





RESEARCH IS KEY

Google is within reach so make sure you research about the company prior to your interview, so that you can appear focused and ready to answer their questions. The physical distance between you two won't allow your recruiter to sense your eagerness for the job. The only way to impress them is to show off your knowledge about the company, and to talk about why you are the one deserving the position. Draw them in with your passion for the company. In addition, don't just be prepared to answer their questions. Be ready to also make professional queries, such as what does a typical day in the life of this role seem like, their goals, the hiring process, their ideal candidate, and so on.



PRACTISE

awkward.

Make sure you practise as well to eliminate extra words from your sentences, such as "um" and "uh" or "like." Perfect your grammar at all costs.

LOOK AT THE CAMERA

Since the setting has been greatly restricted in a virtual interview, all the more that your recruiter will pay attention to your body language. Amongst the no-no's are slouching, yawning, or fidgeting.

To exude an ambiance of confidence and professionalism, make sure to sit up straight, smile, look at the camera while answering their questions so as to maintain an illusion of eye contact. Some experts believe that recruiters will likely remember what you said if you maintain your eye contact, so make sure to look at the camera and not on the image of your potential employer when talking.

Also, because you won't have the benefit of a face-to-face connection, your body language becomes even more obvious - and important to manage - in a virtual interview.

E-WRITE A THANK-YOU LETTER

Within a day after the interview, send a thank you e-mail to your interviewer to let them know your appreciation for them taking their time to accommodate you, as well as your interest in your position. Doing this shows that you genuinely want to become a part of their team, and will increase your chances of getting remembered. It also provides you an opportunity to resell yourself and talk more about your strengths you were not able to address during the interview. Keep it concise yet engaging in order to leave a lasting impression.

In a research by recruiting software Jobvite in May 2020, 58 per cent of recruiters are now turning to LinkedIn, Facebook, and even Instagram in order to connect with applicants as well as do background checks on people who can be part of their team. In addition, 84 per cent of them are now using video calls to screen and interview candidates, while more firms have started using analytics tools and AI to easily scan CVs and narrow down their applicants.



The importance of practising for a job interview - virtual or in-person - cannot be stressed enough. Have a mock interview with your friend or a family member and rehearse with them the questions that the employer may ask you in general, as well as icebreakers and other topics that you can open up to further generate the employer's interest in you. You don't want to sound robotic throughout the engagement, so make sure you practise your communication skills in such a way that it comes off smooth and not

THESE INCIDENTS HAVE TURNED WHAT'S ESSENTIALLY A SPACE FOR DELICIOUS DELIGHTS INTO GRUESOME MURDER SCENES

DATING RIDDLE WHERE: COWAN, INDIANA, US WHEN: MARCH 2008

Wrestling coach Garth Rector, 48, lived alone in a small rented house in Muncie, Indiana, after being separated from his wife. While people saw him as a wildly popular coach, his friends and family remember him going through a midlife crisis.

On March 21, 2008, Rector arrived home with his bag of groceries and a soda. As he stepped inside, someone was already waiting for him with a gun in his hand.

"Looks like he just sat a grocery bag and a cup down and the next thing you know, he was getting shot at," said Kurt Walthour, Delaware Co. Sheriff's Department in a media report.

Investigators revealed that Rector was shot five times, execution-style, in his own kitchen. It was the victim's landlord who found the body. The cops found evidence that there was forced entry, but they were puzzled about the motive of the crime.

Then, the investigators found out that Rector had been dating several women at the same time - one of them was



even married during their affair. Authorities speculated that the murder might have been linked to a robbery gone wrong or perhaps a jealous lover seeking revenge. Neither of these has been proven true.

To date, the case remains unsolved, the killer is still on the loose.

STABBED COUNSELLOR

WHERE: WORCESTER, NORTH CAROLINA, US **WHEN: MAY 2020**



Traci Swan lived a fulfilling life of helping teenagers recover from addiction – up until her untimely demise on May 26 – marking the first homicide at Worcester, Massachusetts, this vear.

Swan's mother Dianna White, along with her family and friends, are still puzzled as to who could have committed the gruesome murder of stabbing Swan at her own kitchen. The

police have charged a suspect, but her mother has more questions about the case.

At the age of 16, Swan moved from North Carolina to Massachusetts during her junior year in high school. White met her boyfriend whom she eventually married – a man stationed at the Marine Corps Base Camp Lejeune.

While she initially dropped out of senior high school, Swan found a job together with her mother at the Dodge Park Rest Home in Worcester, where she worked for the next seven years. There, she earned her GED and eventually became a Certified Nursing Assistant through tireless efforts.

Swan became a mom herself when she turned 24. Her motherhood years also became her time to shift jobs towards becoming a counsellor for teens who were battling addiction.

Authorities said Swan was stabbed at her own kitchen when she was trying to mediate between a man and 29-year-old Naomi Lawrence, whom Swan knew for around six years. A neighbour called 911 after the voices in the argument grew louder and louder.

Lawrence has been charged with battery with a deadly weapon and assault – but White still thinks that there are details missing as regards the death of her daughter.

"When it came to other people fighting, she would do her best to diffuse it. I have so many questions about it," said White, who is still left wondering what really transpired in her daughter's final moments.

STRAY BULLET WHERE: BIRMINGHAM, ALABAMA, US **WHEN: JUNE 2020**

It was a regular, peaceful midnight for 64-year-old Bernice Taylor, as she casually walked through her kitchen to get something for the night. But that turned out to be her final moment when a stray bullet fired outside came in through the kitchen window and struck her.

Her 33-year-old son, Demetrius, called the emergency hotline to report that Taylor was shot. When officers arrived at the scene, he told them that Taylor was already wounded and unresponsive due to a gunshot wound.

"I was sleeping in my bedroom and I heard about four or five shots. I woke up and looked out of my window to see where it came from. I went to check on my mother. I looked in the kitchen, and she was on her back. Once I saw her body, I just freaked out. I kept saying, 'Mama, Mama.'" recalled Demetrius.

Birmingham Police Department officials state that several shots had been fired at the parking lot outside Taylor's apartment. The fatal bullet that struck Taylor seemed to be a mere case of the wrong place and the

KITCHEN BURIAL

WHERE: KANCHARAPALEM, VISAKHAPATNAM, INDIA WHEN: FEBRUARY 2013



Local residents complained of a particular foul smell that emanated from a house located in Kancharapalem, Visakhapatnam in India. When authorities began to dig from the freshly-cemented area in the kitchen, they found a woman's body buried underneath.

The bizarre incident revealed the killing of 45-year-old Vasupalli Arramma, who was one of the fisherfolk within the community. Police found that Arramma's body had





wrong time as no arrests were made immediately after the shooting.

Demetrius said, "She went to work, and she came home. She was sweet, very, very sweet. She was a hardworking mother who raised us to be good people."

several stab wounds and that one of her hands was missing.

Her body was placed within kitchen planks commonly used by locals to store LPG cylinders. The killer apparently sealed the area with cement after killing Arramma.

Arramma's relatives shared that she had a small-time finance business aside from her business of selling fish. They recalled that she gave a loan of Rs 50,000 (Dhs2,480) to a certain person named 'Vasu'; when it was time to repay the loan, Vasu defaulted. Arramma was said to have had an argument with Vasu, who then promised to pay her in February 2013. Then Arramma mysteriously vanished after heading towards Vasu's home. When she failed to return home, her family lodged a missing person complaint in the area. A few days later, the local residents complained of the foul smell and Arramma's body was uncovered.

The police arrested Vasu, and a murder case was lodged against him.

Arramma's death caused a clamour amongst the women in her area, with calls for severe action against her killer.

ampered by her parents and showered with gifts, 23-yearold Hanadi had turned into a rather spoiled individual. Her parents gave her money, jewellery anything and everything – without ever asking any questions, such as "When did you go out? Where have you been? Why are you so late?"

In the absence of any parental restraints, Hanadi lost the ability to tell right from wrong – and so began the downward spiral of her life.

She began an affair with a 30-yearold man named Hamad, who faked his love and dragged her into the trap of narcotics. He seduced her and fooled her with common-law marriage. The beautiful Hanadi didn't have the sense to protect herself.

From the use of narcotics, Hanadi was soon pushed into drug trafficking by Hamad. It was a terrible path that she was treading; eventually, it led to the humiliation and punishment of being arrested and jailed.

In a conversation with her 25-yearold friend Fawzia, the misled Hanadi described how she allowed Hamad to destroy her future.

Hanadi recalled that the worst part of their relationship began when she became addicted to the use of narcotics and also to the excesses of overspending. She said, "After I became addicted to drugs, it was my beloved Hamad who dragged me into this path. The money that I received from my parents wasn't enough for me, especially after Hamad could no longer buy me material things. He asked me to support him financially and stand by his side in this difficult time."

Taking a deep breath, shaking her head several times, she added, "Unfortunately, it was this request that destroyed my life. In an intimate meeting with Hamad, he explained to me that the easiest way to earn money was drug trafficking. In the beginning, I rejected this idea, and also expressed my fear and panic about what he was saying and where it could lead us. He then bluntly told me that this was the only way for us

to be high and earn money." Listening to this story, Fawzia asked Hanadi told Fawzia, "Yes, we So, then, what got her and Hamad

It instilled reassurance in my heart, and I became good in this field, as it became easy to earn money out of it." arrested, asked the friend. Hanadi said, "We thought that we were very smart, and that we could compete with everyone in drug trafficking, and that we would never fall into the net of police. But the truth is: we were monitored all the time. The police also had an eye on Sager, who used to supply us with drugs. I was seen frequently visiting suspicious



places with Hamad, I don't know how the police knew about it but, eventually, Sager, Hamad and I were arrested all together."

As she was fascinated, Fawzia said, "Tell me about the moment you got caught." Remembering the anguish of that time, Hanadi said, "Those moments were very difficult. I looked like a weak bird with a clipped wing, and Hamad appeared at that time weaker than a fly, frightened and terrified.

"That day, the Drug Control Department knew beforehand that we would receive large quantities of drugs, from one of the stores that sold nuts and spices and was owned by Sager - it was located in one of the old markets in the emirate. We found ourselves surrounded, with no ways to escape."

Fawzia then asked how Hanadi's parents reacted when told about their daughter's arrest and how she felt upon being sentenced to prison.

A distraught Hanadi said, "It was a huge shock for my parents when they were summoned to the police station, where they saw their only daughter, thrown into one corner of the place, crying and regretting her deeds. They cried painfully, too, as if they knew deep inside that they had over-indulged her, without asking her about the secret of her frequent absence from the house."

About her trial, she said bitterly, "That's when I cried so badly, cursing my life and Hamad. I regret the days during which I was tempted with money and could not see the disaster I was walking into."

Crying while telling Fawzia the story, Hanadi concluded, "While I spend my time in jail, I will seek God's pardon, and will leave those reckless deeds behind me.'



EARLY DAYS OETHE EMIRATES

THE BOOK GULF GUIDE GIVES US A LOOK INTO THE SOCIAL MIX AND COMMERCE IN THE LANDS THAT LATER BECAME THE UAE

e have been exploring the Middle East through the accounts of John Gordon Lorimer, a British political resident in the town of Bushehr. Persia and author of the 1908 book Gulf Guide, reprinted in 1970.

The geographical section in the second part of Gulf Guide contained news and descriptions of some areas in Iraq, Oman, as well as the UAE.

About Abu Dhabi, Lorimer wrote: "Abu Dhabi is one of the Arab emirates on the Gulf coast and the largest. The main areas of Abu Dhabi from west to east include: Al Majn, Sabkhat Matti, Al Dhafra, Liwa, and Al Khatim. The islands of this emirate are: Arzana, Deeneh, Dalma, Das, Qarnain, Yas, and Zirkuh. As for the capital, it is the city of Abu Dhabi and is located in Al Jazirah. The largest building in it is the Sheikh Fort. There is also a separate market for Indian merchants, the port is located 2 miles away, and behind the city there are some palm trees. Water is extracted from a place that is 3-4 miles away from the city, at a depth of 4-5 feet from the surface of the

earth. To the south of the city, there is the large, shallow Khor Al Bateen Lake. "The population of the Abu Dhabi may reach about 6,000 people, half of them from Bani Yas and the rest from other tribes. The tribes of Bani Yas are as follows: Albu Falaj (40 people), Al Kubaisat (380 people), Al Muharba (300 people), Albufalasah (200 people), Al Qamzan (250 people), Albomhair (500 people), Al Sudan (375 people), Al Murar (200 people), Al Thumairat (120 people),



Albu Amim (number is not mentioned), Al Khmarah (375 people), and Al Halamah (75 people). There is also the tribe of Baharnah, in addition to an Iranian and Hindu community.

"Abu Dhabi residents earn from pearl diving, fishing and simple commercial exchange. They do not have agriculture and palm trees are very few. There are 750 camels and 85 horses; all belong to the sheikh and his family except for five of them. Internal trade is not significant and takes place only with Al Buraimi (Al Ain). In the city, there are about 70 stores, 40 of them for Persians, nine for Hindus, and 10 for Arabs. Hindus import cloth, rice, coffee, and sugar. They also deal in pearl trades. Commercial interests of the Hindu community whose members are from Tata region in Sindh. Most of them accompany their families to India on vacation once a year, and their number doubles in the pearl season.

"In the sheikhdom, there are about 410 pearling ships; 50 of them are in Al Bateen and the rest are located along the

coast, as well as in the islands. There are about 10 ships going to Bahrain, Lengeh, Basra, and Muscat. The ruler is Sheikh Zayed bin Khalifa, the most powerful figure in the Trucial Coast of Oman at the time. His influence not only prevails in the region, but also extends to Al Buraimi and to the town of Ibri in Oman. As for the ruler's financial resources, they are calculated as follows:

- Taxes on pearls: \$57,000 (Dhs209,400)
- · Taxes on pearls of Dalma island: \$5,000 (Dhs18,364)
- Taxes on Liwa's agriculture: \$2,500 (Dhs9,182)
- Taxes on Al Ain's dates: \$5,000 (Dhs18.364)
- · The financial aid given by the Sultan



of Oman to the Sheikh to maintain the security of the region: \$3,000 (Dhs11,018)

Thus, the total reaches about \$750,000 (Dhs2.8 million) annually.

"Speaking of Al Dhafra, it is a large area that includes several separate areas, namely Al-Taf, Bainounah, and Liwa. The water from AI Dhafra's wells is of a good quality, and the wells are all fenced with palm leaves. The population of Al Dhafra is limited to two tribes, the Bani Yas and the Manasir. Bani Yas are a settled tribe, while the Manasir are wanderer Bedouins. Both tribes live in Liwa in villages called Al Wahidah, and the houses are similar to huts made of palm leaves and fronds. Al Dhafra is the main pasture area for Al Manasir, while Bainounah is the preferred pasture area for the Bani Yas, who participate in pearl-diving operations and

have a number of ships that they keep in the port of Radeem and Marfa. The population of Al Dhafra is estimated at about 6,500 people."

A GLIMPSE OF DUBAI

Then, Lorimer described Dubai. He wrote: "Dubai is an independent Arab sheikhdom located between Sharjah and Abu Dhabi. It is connected with Sharjah through the coast of Abu Hail and with Abu Dhabi through Ghanadhah creek. Jebel Ali is located inland for long miles, and it is the only mountain on the coast with a height of 220 feet. The village of Jumeirah consists of 15 houses built of palm fronds, all of whose people are fishing. And the sheikh has about 100 armed men with rifles.

"As for Dubai city it lies on both sides of a shallow creek, whose entrance stretches several miles in the southeast direction. There is a dock for ships and the city is divided into three neighbourhoods, the most important of

which is Deira - it is located on a 20-feethigh land tongue, and has a palm farm.

"In Deira, 1.600 homes are resided in by Arabs, Persians, Baluchis, and others, and its market has 350 stores. There is also Al Shindagha area, which is closer to the sea and has 250 houses. All its residents are Arabs, and Indians are not allowed to live there. As for the city of Dubai, it contains 200 houses, 50 stores, the main mosque. and some ruins that are said to be the remains of a Portuguese castle. Most of the Indians live in this neighbourhood, and transport boats operate between Deira and the city. Also, the people of Deira cross on Fridays for free to perform prayers in the grand mosque.

"Dubai's water is safe for human consumption and the depth of its wells is between 5 and 30 feet. The city was surrounded by a wall, but it no longer exists. On the opposite side of the land, there are a number of towers to defend the city. The population of Dubai is 10,000 people, perhaps more, and they are from Albu Falasa of the Bani Yas tribe with 440 houses; Albu Mhair, with 400 houses; and different tribes, especially from AI Mazarei and Al Sudan with 250 houses; in addition to Al Murr, with 30 houses.

"There are some people from Kuwait and Bahrain, and they have 400 houses, and the Baluchis have 250 homes. All of them

follow the Maliki school of thought. There are also 67 Hindus and 23 Khaja residents. Dubai has 400 palm trees, but their crops are minimal. The number of pearling ships is 135, in addition to 50 fishing ships and 20 sanbuk and Badan ships. Also, between 10 and 12 ships are annually built.

"Dubai's trade is significant and is "Indian and Persian ships frequently

expanding very quickly, thanks to the policy followed by former sheikh Maktoum bin Hasher and as a result of the severe customs restrictions applied by the Imperial Customs Administration in Lengeh. Merchants of Lengeh have immigrated to Dubai, which has established its position as the centre of foreign trade in the UAE. visit Dubai, while the British visit once every two weeks, and ships from other



countries arrive on an opportunity basis. Local exports are pearls, shells, and dried fish, while imports are dates brought from Basra, Minab, and Al Batinah. The imports also include rice, wheat, spices, minerals, fibre ropes and wood from India. In the city, there are about 400 shops and 300 stores, and there are 23 Hindu merchants and 7 Khaja residents."

OTHER PARTS OF THE EMIRATES

After Abu Dhabi and Dubai, Lorimer described the other lands that form present day United Arab Emirates. His accounts are as follows:

FUJAIRAH: "It is located 15 miles south of Khor Fakkan, in a place close to Wadi Ham along the shore and 2 miles from the sea. Its castle is located to its south and at a distance of 7 miles from the sea, and the number of palm trees in Fujairah is about 3,000. The city is surrounded by a 4-feet-high wall, and fresh water is found in wells at a depth of 4 feet. There are also 150 houses, most of them made of mud, stones and a little bit of cement.


"During the date harvest season, residents set up makeshift villages. Most of the residents of Fujairah are from Al Hafeetat, and they earn from palm cultivation, some tobacco and grains, and pearl diving. Fujairah has been ruled by Sheikh Hamad bin Abdullah Al Sharqi

since 1901. The subordinate divisions belong to Fujairah, namely, Al Bathna, Al Gharfa, Mirbah, Qadfa, and Sakamkam, In addition, the Sheikh has a good relationship with the Sheikh of Abu Dhabi." KHOR FAKKAN: "Khor Fakkan is located on the southern shore of a sandy bay that is 2 miles wide and 1 mile deep and open towards the northwest, and has a port suitable for docking. There is an island with a height of 240 feet, which is known as Sira Al Khor. In Khor Fakkan, there are also farms that contain 5.000 palm trees, and there are about 150 houses for Al Nagbi tribe and some Persians. Its population is about 800 people who cultivate palm trees, wheat and dive for pearls. Also, there are about 4 or 5 ships that are used for travelling to Muscat. As for the ruler of the city, he is Sheikh Saeed bin Ahmed, the cousin of the ruler of Sharjah."

RED ISLAND: "It is also called Zaab Island, located 12 miles southwest of Ras Al Khaimah. The island is 2 miles long and is almost connected to the mainland from its southwestern tip, and when the tide is low in the bay separating the island and the land, it can be crossed on foot. It consists of 500 houses for the Zaab tribe, and it is divided into two neighbourhoods: one in the north, which is small and called Umm Oweimer: and the second in the south, which is large and called Al Manakh. Residents have about 100 camels, 150 cows and 500 goats, and they have 25 pearling ships and 100 small vessels to bring firewood and sell it in Sharjah and Dubai. Generally, the people of the Red Island earn from pearl diving."



AL HAMRIYAH: "It consists of 300 houses and a castle, several towers. and six shops. The residents include the sheikh from Al Darawshah family of the Naim tribe, with some from the Tanij tribe. They have 117 pearling ships and 1,000 palm trees, 60 cows and 150 goats. As for the sheikh, he is Abdul Rahman bin Saif, and he is not recognised as an independent sheikh by the British government, and not given an official salute, and the Sheikh of Sharjah usually accompanies him to meet with British officers. This sheikh collects about \$4,520 (Dhs16,000) a year as pearl tax and has farms in Al Dhaid as well.'

AL DHAID: "[It is] an isolated town located in the heart of Ru'us al-Jibal and belongs to the emirate of Sharjah, and [is] located about 30 miles to the east and 33 miles to the south of Ras Al Khaimah.

"It is a centre of some political and geographical importance. AI Dhaid contains about 140 houses, of which 70 are for the Tanij tribe, 40 for Bani Qatab, and 30 for AI Khawater from AI Naim tribe. Each of the tribes has a fortified tower, and on the eastern side of the town, there is a castle with four towers for the Sheikh of Sharjah. The palm farms form an area of about 1 mile and they are irrigated by a rich well with a width of about 3 feet and a depth of 2 feet. Its water can be counted in preparation for the irrigation process. The water is fresh and transparent; it has a strong flow and is distributed carefully, and the person responsible for distributing water is the representative of the Ruler of Sharjah. Also, palm and wheat are grown on farms.

"Al Dhaid is ruled by a wali who receives orders from the Sheikh of Sharjah and his mission is to maintain security and discipline. He resides in the Sheikh's castle and raises the flag of the Trucial Oman coast on the northwestern tower. The revenues of the Sheikh of Sharjah from Al Dhaid are around 100 pods of dates. He also receives about \$228 (Dhs840) as fees for the water used by farmers. Al Dhaid belongs to the ruler of Sharjah, and Sheikh Salem bin Sultan, the uncle of the ruler of Sharjah, as well as the sheikhs of Ajman and Hamriyah own some palm farms in there.

"According to a report, Al Dhaid can be the best location that British and Indian forces can land in, if needed. The water there is fine and abundant, and there are a lot of camels and other animals. Also, it is possible to reach Al Dhaid from Ras Al Khaimah by carriages."





UAE's aquaculture industry sees rise in yield

THE UAE witnessed a growth in fish catches during the first half of 2020 across certain. species of economic importance, buoyed by the implementation of seasonal fishing and trade bans.

Arabian safi (emperor) catch saw a 30.8 per cent increase while sheri (rabbitfish) catch witnessed an increase of 17.4 per cent compared to the same period last year.

HE Dr Abdullah Belhaif Al Nuaimi, Minister of Climate Change and Environment (MOCCAE), praised the compliance observed amongst fishermen and businesses, stating that the seasonal fishing and trade bans had been effective in both the regulation and propagation of the UAE's aquatic resources.

"Achieving food security and sustainability is a strategic priority for the Ministry. Therefore, we work to develop all local food production sectors, including fisheries. Our success in this regard depends on the awareness of fishermen about the importance of fishing regulations



for ensuring the sustainability of the fishing occupation in the UAE, and the extent of their compliance and cooperation with the Ministry and concerned local authorities," said Al Nuaimi.

He highlighted that MOCCAE intends to further boost these numbers and introduce new initiatives to motivate fishermen for their contributions with subsidised equipment such as boat engines, and collaboration with local authorities to develop fishing ports and facilities

in the country. The Ministry will also aid in the rehabilitation of several marine habitats through the installation of 3,200 artificial caves, an initiative to plant 30,000 mangroves, fish hatchery projects in select coastal areas, and coral culture

To date, there are 12 aquaculture farms registered with MOCCAE. They produced 3.223 tonnes of fish in 2019.

Drones put UAE at the forefront of food security—eco protection integration



THE UAE's adoption of drones in agriculture has made it one of the firsts in the world to integrate technology in food security and environmental protection, according to Falcon Eye Drones Services (FEDS), the Middle East's leading and one of the world's top Drone-As-A-Service (DaaS) companies.

FEDS' statement comes on the heels of the announcement of His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice President and Prime Minister of the UAE and Ruler of Dubai, that the UAE is amongst the first in the region to prioritise environmental protection and climate change as part of its food sustainability programme on a national scale.

Earlier, His Highness Sheikh Mohamed bin Zayed Al Nahyan, Crown Prince of Abu Dhabi and Deputy Supreme Commander of the UAE Armed Forces, also stressed the value of utilising agricultural technology approach—also known as AgTech—to enhance home-grown food production.

Underscoring how the UAE has been a pioneer in the region for massive drone-planting initiatives, FEDS CEO Rabih Bou Rashid emphasised how drones are revolutionising the agricultural sector in response to rapidly evolving needs of our time and how technology-driven projects in the country have proven that drones are a more cost-effective and faster alternative to traditional farming

methods being practised for millennia. In partnership with the Ministry of Climate Change and Environment, FEDS had undertaken a massive drone seeding initiative in 2019 that saw the planting of 250,000 Ghaf seeds and 6 million Samar seeds in 150 square kilometres of land in a few days—a process that used to take decades to complete through traditional farming methods. This feat has made the UAE one of the very first countries in the world to conduct a drone-planting project on such an expansive scale.

"With the changing calls of our time, such as the repercussions of COVID-19 ringing in amongst nations to produce more of what they eat, countries see the need to explore newer solutions to boost their agricultural sector. If we look at the future of farming in the UAE, drone systems would be as common as tractors, unleashing the benefits of precision agriculture to ramp up farming," Bou Rashid said

He added that drones' ability to conduct seeding, land surveying initiatives will propel the UAE's goal of environmental protection and National Food Security Strategy 2051. The country ranks 21st globally in the latest Global Food Security Index 2019 report, achieving a 10-place leap from 2018, and besting other nations in the West and in the Middle East.

UAE surpasses target number of volunteers for COVID-19 vaccine trial



THE UAE's Phase III trial of inactivated vaccines for COVID-19 has set a new global record after recruiting 31,000 volunteers, surpassing the required target of 15,000 – that's more than 200% of the goal met.

Participants in one of the largest vaccine trials in the world were from more than 120 nationalities.

The Department of Health - Abu Dhabi (DoH) confirmed in the latter part of August that there was already a sufficient number of volunteers required to complete the clinical trial, so no new registrations would be accepted. The vaccine centres at ADNEC and Al Qarain Centre in Sharjah have stopped receiving volunteers. They remain open, however,

for those receiving the second shot of the inactivated vaccine.

Commenting on the achievement of securing this many volunteers, HE Abdul Rahman bin Mohammed Al Owais. Minister of Health and Prevention and Minister of State for Federal National Council Affairs, said, "From the very onset, the UAE leadership was totally committed to overcoming the COVID-19 pandemic through a global collaborative effort. The public-spirited nature of citizens and residents and their willingness to volunteer is a powerful endorsement of the proactive approach the UAE has taken in what is a world-leading inactivated vaccine trials programme.

"Everyone involved in the trials, from the volunteers to the clinical and administrative staff, can be enormously proud of what has been achieved already, showing once again the sense of unity and shared purpose that has driven the nation for the past five decades."

The vaccine passed the first two phases of clinical testing without causing any side effects to the volunteers.

University of Sharjah gets grant to develop COVID-19 antiviral drug

THE University of Sharjah has won financial backing for its bid to develop an antiviral drug against the novel coronavirus disease (COVID-19).

The university received grants for two projects that aim to alleviate the spread of COVID-19. It also undertook a sponsored agreement with a UAE enterprise fund named Sandooq Al Watan to support their research.

Led by Dr Sameh Soliman and coinvestigators Dr Ahmed Almehdi, Dr Rania Hamdy, and Dr Mohamed Haider from the University of Sharjah, the initiative is expected to produce a dual-inhibitor antiviral drug to combat the transmission and presence of the disease. Researchers aim to do it through blocking the enzymes necessary for viral infection.

Ahmed Fikri, Acting Director General of Sandoog Al Watan, said, "As a national initiative supporting research projects for the post-oil era, the recent major disruptions



caused by the novel COVID-19 outbreak have made it even more imperative that we aid innovative and forward-thinking projects to support national efforts to curb the spread of the virus and ensure business continuity in the UAE.


